SHELTER, BEHAVIOR & TRAINING: THIS PROGRAM PROVIDES SHELTER AND CARE FOR HOMELESS ANIMALS, ADOPTION SERVICES, LOST AND FOUND PET SERVICES, HUMANE EUTHANASIA OF SICK OR AGGRESSIVE ANIMALS, BEHAVIOR MODIFICATION FOR SHELTER ANIMALS AND PET TRAINING TO THE PUBLIC, AND COORDINATION OF VOLUNTEERS. IN 2014, OUR SHELTER HAD 7,107 INCOMING COMPANION ANIMALS, INCLUDING 149 OWNER/GUARDIAN REQUESTED EUTHANASIA. WE ADOPTED 5,098 PETS TO NEW HOMES, AND 1,138 PETS WERE RECLAIMED BY THEIR OWNER/GUARDIAN. OUR LIVE RELEASE RATE WAS 93%. OUR TRAINING AND BEHAVIOR DEPARTMENT SERVED 5,405 CLIENTS TAKING A TRAINING CLASS OR PRIVATE CONSULTATION. THE DEPARTMENT REHABILITATED 510 DOGS AND CATS THROUGH ITS BEHAVIOR MODIFICATION PROGRAM. IN 2014, OUR VETERINARY CLINIC PEFORMED 3,523 SPAY AND NEUTER SURGERIES AND SAW 9,984 APPOINTMENTS, INCLUDING 1,022 LOWER INCOME CLIENTS RECEIVING A SHARE PROGRAM DISCOUNT.
